# **Recruitment Begins for Seven Quality Improvement Tasks**

IQH project leaders have begun recruitment throughout the state, enlisting participation in seven quality improvement tasks that represent the commitment of the Centers for Medicare & Medicaid Services (CMS) to driving rapid, large-scale change for Medicare patients. The CMS commitment includes contributing to better patient care, better population health and lower costs through improvement. The five-year statement of work that began Aug. 1 builds on the experience gained in the 10th statement of work and other previous contracts.

### Tasks include:

Cardiac Health and Reducing Cardiac Healthcare Disparities; Disparities in Diabetes Care;

Prevention Coordination through Meaningful Use of HIT; Healthcare-Associated Infections in Hospitals; Healthcare-Acquired Conditions in Nursing Homes; Coordination of Care for Patients; and Value-Based Payment Program, Quality Reporting and Physician Feedback Program.

Tasks are goal-oriented toward making care safer and promoting effective communication and coordination of care. Goals also emphasize promoting effective prevention and treatment and best practices for healthy living.

IQH is a subcontractor in atom Alliance, which serves as a Quality Improvement Network-Quality Improvement Organization in CMS's restructured QIO program.

# Paint It Purple Event Set for Sept. 19

A statewide campaign is planned for Sept. 19 to encourage a show of support for people with Alzheimer's disease and their caregivers. Supporters are urged to wear purple and display purple ribbons and bows at their homes and businesses. Statistics show that some 51,000 Mississippians live with the disease, with a projected estimate for 2025 numbering more than 65,000 having the disease. Deaths have increased from Alzheimer's. About 80 percent of the care at home is provided by family caregivers. The Alzheimer's Chapter, the Mississippi Department of Mental Health, and the UMMC MIND Center are sponsoring the campaign. Two IQH staff members, Mae McDaniel and Brenda Townsend, are currently working with the local Alzheimer's Association chapter.
